### AIMS OF THE PROGRAMME

This programme aims to develop critically informed, agile and resourceful graduates, who:

- have the versatility and personal qualities to manage a range of journalism activities in any context ie local, national and/or international;
- are committed to critical and creative independence in individual and group work and production;
- have highly-developed interpersonal skills ;
- are able to manage their own personal development and lifelong learning.

Journalism, is undergoing huge challenges and changes and the degree continues to reflect and lead in terms of educational and employability skills on a yearly basis, often by the use of minor modifications on specific units where necessary. The MA Multimedia Journalism degree has always been responsive to students' needs, feedback from academic external partners, employers and increasingly digitally focused methods of storytelling.

The existing MA Multimedia Journalism framework and programme is accredited and scrutinised by the nationally-recognised Broadcast Journalism Training Council.

The MA Multimedia Journalism makes a unique offering in the UK in its breadth as a conversion degree. Its goal is to address the convergence of print, radio/audio and television/video journalism into a single electronic digital platform and setting this convergence in the context of the globalisation of media organisations and media products. Students are expected to develop a portfolio of work deploying and demonstrating core journalism skills in a variety of media. At the same time, optionality allows students to develop further skills in emerging journalism platforms with immersive journalism, documentary and investigative Journalism.

In addition, the degree has a solid academic underpinning. Journalism in Global Contexts, Legal and Ethical Context, Media and Global Challenges, and the Journalism Project all help to develop reflective and critically aware graduates who can function competitively and flexibly in a variety of journalistic environments.

Multimedia Journalism is offered as a stand-alone framework. To retain MAMMJ's reputation and recruitment, it has continued to innovate, foster industry stakeholders and recruit new members of staff to ensure the programme is pedagogically and technologically sound. Adaptations (minor modifications) have been made to the degree to make it responsive and relevant. The inclusion of Immersive and Interactive Storytelling allows the degree to be at the heart of an ever-changing industry and nurture responsive and adaptable journalists. Specifically, digital journalism and a multiplatform approach have contributed to a degree which embeds convergence skills while other units also stay theoretically and analytically abreast of changing journalism and communication developments: a coherent degree built on quality journalism underpinned by digital skills and intellectual rigour.

MA Multimedia Journalism aims to develop postgraduates who can deploy online and digital technologies for journalism work in a legal, ethical and critically-informed manner. It aims to develop the research capabilities of students in the field of online and digital journalism, and their understanding of key issues in journalism at a time of technological change.

## LEARNING HOURS AND ASSESSMENT

Bournemouth University taught programmes are composed of units of study, which are assigned a credit value indicating the amount of learning undertaken. The minimum credit value of a unit is normally 20 credits, above which credit values normally increase at 20-point intervals. 20 credits is the equivalent of 200 study hours required of the student, including lectures, seminars, assessment and independent study. 20 University credits are equivalent to 10 European Credit Transfer System (ECTS) credits.

The assessment workload for a unit should consider the total time devoted to study, including the assessment workload (i.e. formative and summative assessment) and the taught elements and independent study workload (i.e. lectures, seminars, preparatory work, practical activities, reading, critical reflection).

Assessment per 20 credit unit should normally consist of 3,000 words or equivalent. Dissertations and Level 6 and 7 Final Projects are distinct from other assessment types. The word count for these assignments is 5,000 words per 20 credits, recognising that undertaking an in-depth piece of original research as the capstone to a degree is pedagogically sound.

## STAFF DELIVERING THE PROGRAMME

Students will usually be taught by a combination of senior academic staff with others who have relevant expertise including – where appropriate according to the content of the unit – academic staff, qualified professional practitioners, demonstrators/technicians and research students.

### **Bournemouth University International College Articulation:**

Applicants from the Bournemouth University International College Pre-Masters in Media and Communication programme which has an approved articulation route must meet the following minimum entry requirements:

Successful completion of the Pre-Masters in Media and Communication programme achieving a minimum course average of 50% and an English exit of 70% with 65% in the Written component and 60% in all other English components.

## WORK BASED LEARNING (WBL) AND PLACEMENT ELEMENTS

The Professional Placement (of 3 weeks or 15 days in duration) is a compulsory and integral part of this course, and its successful completion is a requirement for the awards of Postgraduate Diploma and MA. It aims to enable students to consolidate in a journalism workplace the academic understandings and practical journalism skills acquired in all units of the Postgraduate Diploma phase of the programme including an appreciation of the place of theory in the context of practice. It is usually conducted in the Easter break but may be carried out in the 3<sup>rd</sup> semester summer period to increase flexibility for students in obtaining places and carrying it out, especially overseas. There is a deadline for submission of placement reports.

#### A – Subject Knowledge and Understanding

This programme provides opportunities for students to:

- engage critically with the academic and professional literature on journalism, including the debates and intellectual themes;

- engage critically with global theoretical perspectives and international professional contexts relating to global journalism and crisis news (forms, practices and audiences).
